A) How many encroachment cases of waqf properties of Bidar District have been filed in Waqf Board, District Courts and High Courts; From how many years they are outstanding and present stage of these cases.	<p>A total no. of 197 cases have been registered in the Karnataka State Waqf Board regarding encroachment of waqf properties in Bidar district and 73 cases have been disposed off out of 197 cases there are 124 pending before the Enquiry Officer/Chief Executive Officer for evidence and arguments from 2016, 2021 and 2022.</p> <p>Further, no cases are pending before the District Court and Hon'ble High Court for encroachment in the Bidar District.</p>
B) Reason for pending of cases for many years; and officers responsible for this pendency;	<p>As the above cases are quasi-judicial in nature, they remain pending before the enquiry officer as sufficient time has to be provided to hear the arguments of both sides.</p>
C) How many cases have been registered against such officers for complicity in encroachment? Who are such officers? And how many Sanctioned posts are there in the department; How many staff are working in them; How many Vacant post are there?	<p>Regarding the waqf property encroachment, the cases are pending before the enquiry officer therefore the action is not initiated against the concerned.</p> <p>There are total 355 sanctioned posts in Karnataka State Waqf Board out of which 131 staff is working and 224 posts are vacant. (Details attached in Annexure-1).</p>
