

5) As per the tender the first year payment is 20% of the bid amount i.e., of Rs. 61.20 Lakhs to be paid to BBMP now the agency has paid of Rs. 25.00 Lakhs through RTGS, IFSC bearing Code No. CNRB0008401 and UTR No-VIJBH12121073769 dated: 30.04.2012 of Vijaya Bank and also the monthly payment of Rs. 3.01 Lakhs which is suppose to pay to BBMP every month by the agency will be adjusted to Rs. 61.20 Lakhs.

- 88) The Lessee appoint only trained life guards and coaches at his own cost with utmost care.
- 89) The expenses towards the required Chemicals, Chlorine, Electricity consumption charges and water consumption charges towards the purification and other equipment, replacement of machinery parts repairs to pump and other repairs etc., required for maintaining the pool in a satisfactory condition is to be born exclusively by the Lessee only.
- 90) The Lessee agrees to hand over possession of the swimming pool to the Lessor in the same condition in which as it was in the condition at the time of handing over to lessee with reasonable wear & tear and also lessee should handover all the equipments and machineries which already installed by the lessee and lessor without any damages.
- 91) The Lessee should withdraw the personals appointed by him immediately after the Lease period is completed and the Lessor will not appoint them or continue them in service after the Lease period is completed under any circumstances.
