Minutes of Meeting of 2nd Technical Evaluation Committee held on 23.06.2017 for evaluation of technical bids for the work of "widening to two lanes with paved shoulder from Km 544.200 to Km 594.000 of NH-15CA Hesmane Cross – Pandavapura Section on EPC mode in the State of Karnataka".

Sanctioned cost: Rs 251.13 crores, Civil Construction Cost: Rs. 196.18 Crores (AP) through Engineering, Procurement and Construction (EPC) mode.

Preamble:

The initial technical bid evaluation committee in respect of the above mentioned work was held on 15.06.2017. In the meeting the committee resolved to obtain certain clarifications/additional information from the following bidders by giving 7days time and to the place the same before the committee meeting to be convened on 23.06.2017.

1. M/s Ramalingam Constructions company Pvt Ltd.

As per the tender clauses 2.2.2.1 for bid capacity, 2.2.2.2 (i) for technical capacity & 2.2.2.3 for financial capacity (net worth) of RFP, the bidder has uploaded the required documents which are satisfying the RFP tender qualification criteria's.

In the joint venture agreement it is noticed that both the lead member & other member has shared equal share (i.e 50%) for this work. As per the Cl 2.2.1 (i) of RFP the share of the lead member should be more than 5% of the other member. Hence, the committee directed the Executive Engineer to obtain the clarification for the same.

The document in respect to Cl 2.2.2.2 (ii) for similar nature of work furnished by the lead member (i.e. V.M & Company) has been verified and it is noticed that the project cost for the work "Rebuilding and widening the existing two lane pavement in km 41/640 - 55/2, 58/0 - 63/4 & 65/2-66/33 to 10.500m width of Thoothukudi - Tiruchendur- Kanniyakumari road including construction of High level Bridge at Km. 54/8 and 7 culverts and protection works (including LA) (SH 176)" is Rs.57.26Cr in which LA cost is also included.

Based on the above findings a confirmation and additional details of work in respect of similar nature of work executed by the bidder has been sought from the concerned Employer and as per Cl 2.2.1(i) a clarification regarding share for Joint Venture is sought from the bidder.

In this connection, the bidder has modified Joint Venture about the percentage of Sharing between Lead member and other members and the confirmation for the work done certificate is also received from the Employer.
